

RESOLUTION NO. 2019-04

A RESOLUTION OF THE CITY OF COATESVILLE, CHESTER COUNTY, PENNSYLVANIA AUTHORIZING THE CITY'S SALE/TRADE OF VEHICLES AND OTHER EQUIPMENT IDENTIFIED HEREIN BY MEANS OF MUNICIBID OR TRADE-IN PURSUANT TO COSTARS PURCHASES FOR NEW VEHICLES, OR BY PUBLIC BID OR AUCTION CONSISTENT WITH THE REQUIREMENTS OF THE THIRD CLASS CITY CODE AND CITY CHARTER

BE IT RESOLVED, by the Council of the City of Coatesville, and it is hereby ordained by the authority of the same as follows:

WHEREAS, The City of Coatesville, a Third Class City and Home Rule Municipality located in Chester County, Pennsylvania (hereinafter the "City"), is authorized to sell personal property by public bid or auction where the value of such personal property is estimated by the City to be worth in excess of \$2,000.00 and the City passes a resolution to sell same in this manner. See, 11 Pa.C.S. §12402.1 (ba and (c); and

WHEREAS, the City has equipment which it cannot use, valued in excess of \$2,000.00, which property (identified hereinafter by Type of Property, Make/Model, year of construction, and hours or miles used) it desires to sell (or trade as permitted by Costars):

WHEREAS, the City’s sale schedule is as follows:

Monday, April 8, 2019 – Placed on Municibid

Tuesday, April 9, 2019 – Thursday April 11, 2019 – Items available for public viewing


Wednesday, April 17, 2019 – Close Bid on Municibid

Monday, April 22, 2019 – Results and approvals before Council


WHEREAS, the City wishes to memorialize its actions so as to permit the City Administration to use those methods best suited to the City’s needs for the sale/trade of these items of City personal property at such time as the circumstances dictate.

NOW, THEREFORE, BE IT RESOLVED that the City of Coatesville by Resolution confirms its authorization to permit the City Administration (City Manager and Director of Finance) to sell/trade the personal property as identified above in part or in whole in such manner and at such time as the City Administration determines appropriate by means of: 1) “Municibid – Online Government Auctions”; 2) a trade-in for some new vehicle or vehicles as is permitted by the State’s “Co-Star Program”; or, 3) sale by public bid or auction in accordance with the Third Class City Code and the City Charter.
