**A RESOLUTION OF THE CITY OF COATESVILLE, CHESTER COUNTY, PENNSYLVANIA
AUTHORIZING THE CITY'S SALE OF
VEHICLES AND OTHER EQUIPMENT IDENTIFIED HEREIN BY MEANS OF MUNICIBID
AUCTION CONSISTENT WITH THE REQUIREMENTS OF THE THIRD CLASS CITY
CODE AND CITY CHARTER**

BE IT RESOLVED, by the Council of the City of Coatesville, and it is hereby ordained by the authority of the same as follows:

WHEREAS, The City of Coatesville, a Third Class City and Home Rule Municipality located in Chester County, Pennsylvania (hereinafter the "City"), is authorized to sell personal property by public bid or auction where the value of such personal property is estimated by the City to be worth in excess of \$2,000.00 and the City passes a resolution to sell same in this manner. See, 11 Pa.C.S. §12402.1 (a) and (c); and

WHEREAS, the City has equipment which it cannot use, valued in excess of \$2,000.00, which property (identified hereinafter by Type of Property, Make/Model, year of construction, and hours or miles used) was put out for bid by means of Municibid with the following highest bid received at the end of the auction terminating on April 17, 2019 in amounts identified below:
