RESOLUTION NO. 2022-13

A RESOLUTION OF THE COUNCIL OF THE CITY OF COATESVILLE, CHESTER COUNTY, PENNSYLVANIA AUTHORIZING OFFICIAL ACTION RELATING TO RECEIVING A MULTIMODAL TRANSPORTATION FUND GRANT FOR THE MULTIMODAL PARKING FACILITY AT THE NEW COMMUTER TRAIN STATION.

WHEREAS, the Commonwealth Financing Authority (CFA) provides Multimodal Transportation Fund (MTF) grants for projects deemed in the public interest within the Commonwealth of Pennsylvania; and

WHEREAS, the Council of the City of Coatesville (Council) desires to apply for MTF grant funding for the construction of a multimodal parking facility to be located adjacent the new commuter train station in the City of Coatesville; and

WHEREAS, the Council affirms that these improvements are in the public benefit and will result in a greatly improved public transportation experience for the residents of the City of Coatesville;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Coatesville that the following actions relating to the MTF grant application are hereby authorized and directed as follows:

1. The Council hereby requests a Multimodal Transportation Fund (MTF) grant of \$2,567,651 from the Commonwealth Financing Authority (CFA) to be used for the construction of a multimodal parking facility at the new commuter train station.
2. The Council does hereby designate Mr. James Logan, City Manager, and Ms. Linda Lavender Norris, Council President, the officials to execute all documents and agreements between the City and the Commonwealth Financing Authority to facilitate and assist in obtaining, receiving, and administering the requested grant.




FURTHER RESOLVED, that all Resolutions or parts of Resolutions inconsistent with this Resolution are hereby superseded.
