AN ORDINANCE OF THE CITY OF COATESVILLE, CHESTER COUNTY, PENNSYLVANIA AMENDING PART II, GENERAL LEGISLATION, CHAPTER 218, VEHICLES AND TRAFFIC, PART 1, GENERAL REGULATIONS, ARTICLE II, PARKING REGULATIONS, §218-7, LOADING ZONES, SUBSECTION C(3)(C) BY DELETING "CHURCH STREET, NORTH (ENTIRE BLOCK)" FROM THE LIST OF SCHOOL ZONES; AND CHAPTER 218, VEHICLES AND TRAFFIC, PART 1, GENERAL REGULATIONS, ARTICLE II, PARKING REGULATIONS, §218-7, LOADING ZONES, SUBSECTION C(3)(B) BY ADDING "17 NORTH CHURCH STREET" TO THE LIST OF PASSENGER LOADING ZONES; AND FURTHER REPEALING ORDINANCE 1590-2024.

WHEREAS, the City of Coatesville ("City") is a Third Class City operating by means of a home rule charter; and

WHEREAS, §2-301.I (Action requiring ordinances) of the City Charter requires that the City pass an ordinance to amend or repeal any ordinance previously adopted; and

WHEREAS, Council desires to adopt this Ordinance to amend certain sections of Chapter 218, Vehicles and Traffic, as set forth below.

NOWTHEREFORE, in accordance with the foregoing authority, which incorporates all rights and powers granted to the City of Coatesville under the Third Class City Code and those powers set forth under its Charter, the City hereby enacts and ordains as follows:

SECTION 1. The General Laws of the City of Coatesville, as amended, Part II, General Legislation, Chapter 218, Vehicles and Traffic, Part 1, General Regulations, Article II, Parking Regulations, §218-7, Loading Zones, Subsection C(3)(c) is hereby amended by deleting the following single entry from the list of school zones:

CHURCH STREET, NORTH (ENTIRE BLOCK)

SECTION 2. The General Laws of the City of Coatesville, as amended, Part II, General Legislation, Chapter 218, Vehicles and Traffic, Part 1, General Regulations, Article II, Parking Regulations, §218-7, Loading Zones, Subsection C(3)(b) is hereby amended by adding the following single entry to the list of passenger loading zones:

17 North Church (Monday through Friday 6 a.m. to 9 a.m., and 2:30 p.m. to 5:30 p.m.)

SECTION 3. Ordinance #1590-2024 and all ordinances or parts of ordinances conflicting with any provisions of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

SECTION 4. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof.

SECTION 5. This Ordinance shall be effective 30 days after publication following final adoption in accordance with the City Charter and the Third-Class City Code.
